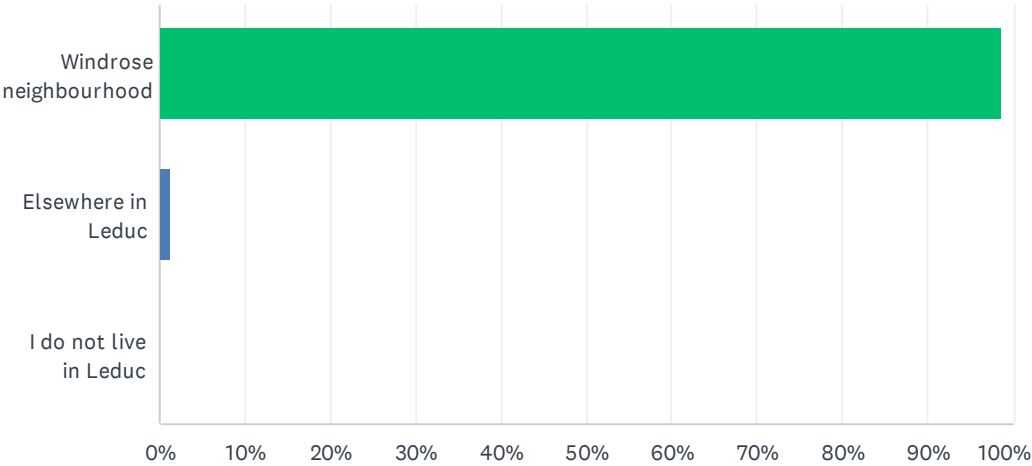


Q1 Where in Leduc do you live?

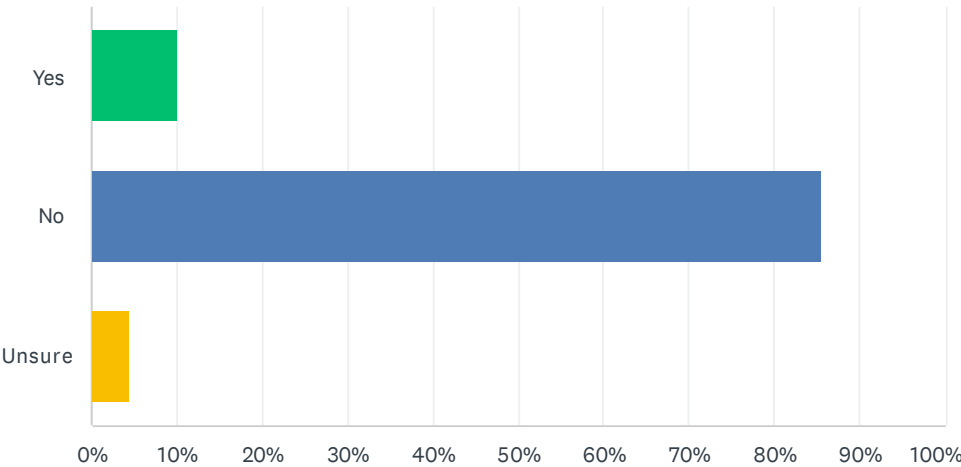

Q2 Do you think the temporary measures implemented should be made permanent? (two nets instead of four)

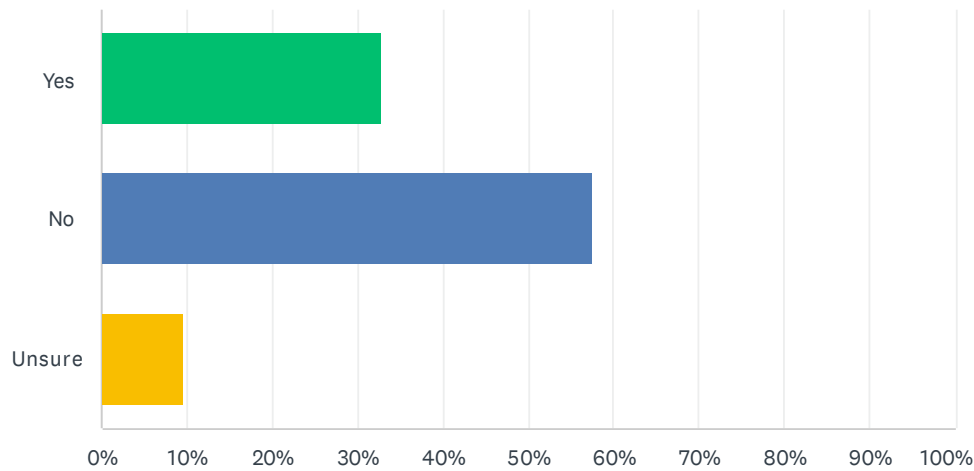

Q3 Do you feel the city should consider putting in a second basketball pad elsewhere in Doris Smith Park to mitigate noise concerns for neighbouring properties?

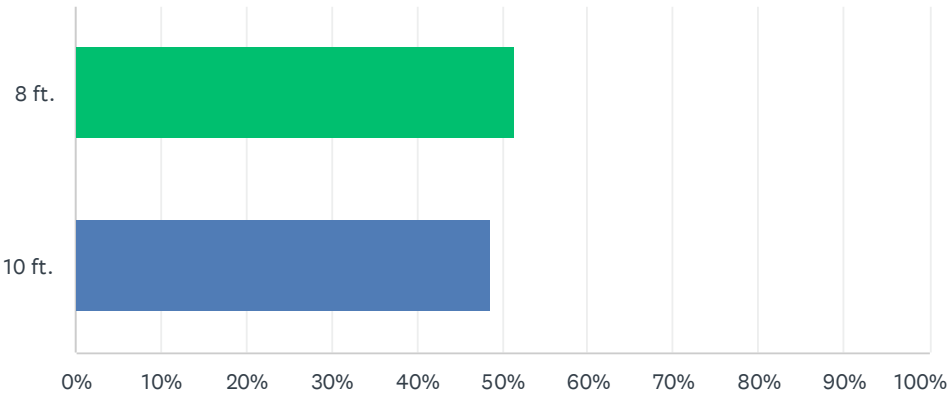
