REPORT TITLE: Bylaw 1156-2023 – Amendments to Bylaw 1138-2022 (1st, 2nd and 3rd Readings)

(Transit Subsidy) (Procedural Correction)

EXECUTIVE SUMMARY

At the June 19, 2023 Council Meeting, Bylaw 1156-2023 was presented to Council for consideration.

A procedural error was made in the passage of three readings to the Bylaw. Therefore, Administration recommends that all three readings of the bylaw be re-done.

RECOMMENDATION

That all readings of Bylaw 1156-2023 made on June 19, 2023, be rescinded.

That Council gives Bylaw 1156-2023 first reading.

That Council gives Bylaw 1156-2023 second reading.

That Council unanimously agrees to consider three readings of Bylaw No. 1156-2023 in the same meeting.

That Council gives Bylaw 1156-2023 third reading.

COUNCIL HISTORY

At the June 19, 2023 Council Meeting, Council approved the implementation of a program to provide subsidized monthly local/LATS and commuter bus passes to eligible City of Leduc residents.

BACKGROUND / RATIONALE

Bylaw 1156-2023 is a bylaw to amend Bylaw 1138-2022 – Fees Bylaw, to allow implementation of the provision of subsidized bus passes, as approved by Council on June 19.

The correct procedures for the passage of Bylaw 1156-2023 were not followed at the June 19, 2023 Council Meeting, which could result in questioning of the legal authority for providing subsidized transit passes.
