

Crime Reduction

- Conduct 10+ Crime Reduction Focused Projects
 - Currently three Project Based Files are underway focusing on Property and Drugs in and around Civic Centre and LRCs
- Conduct 6+ prolific offender focused Initiatives including Prolific Offender Checks & Warrant Round Ups
 - We have already surpassed our goal in completing and reviewing eight initiatives.
 - These include: Prolific Offender Program, Warrant Round Up, Hot Spot Policing Checks (vehicle and foot patrols), Project Hall Pass - Monthly check ins of Parolees, Bait Vehicles/Equipment, School Presentations, Local Business Crime Prevention Presentations, Anti Fraud Crime Prevention Presentations
- Conduct 6+ Auto theft / Auto Crime Focused Initiatives including the Bait Vehicle Deployment
 - Anti Auto Crime Event ("Locking Licence Plate Screw") 81 vehicles attended and had locking screw installed
 - o Two Auto theft Project Files are currently be investigated.
- Intelligence Led Policing
 - O An increased focused has been placed on intelligence lead policing by utilizing an crime analyst to focus resources, recognize crime trends and identify suspects. Members are being provided training in cultivation and handling of Confidential Informant in order to extend our intelligence beyond traditional policing techniques.

Illegal Drugs

The Leduc Drug unit is currently on track of meeting the 20% increase goals set for projects and warrants.

During this quarter the unit has written 11 Judicial Authorizations on active investigations in the first quarter. The Unit has also started 4 new investigations that will carry over into the next quarter.

The unit has successfully seized over \$50,000 of drugs before they hit the streets of Leduc.

Enhanced Road Safety

- Reviewing shift reports and speaking with Watch Commanders. Members have been active and patrolling the school zones during school hours. There has been an increase in recorded patrols to school zones and related enforcement during school times.
- JFO's to be planned in the coming months with enforcement partners.



Leduc Municipal Detachment - 2023 Crime Severity Index

The Leduc Municipal Detachment's 2023 CSI value is 84.6. This is a decrease of 0.6% when compared to the newly revised 2022 CSI value of 85.

The overall CSI in Alberta for 2023 was 103.0, a 2% decrease when compared to 2022.



Main Contributors and Drivers to CSI

The table below contains the top 10 contributors to the Leduc Municipal Detachment's CSI in 2023.

In 2023 Break & Enter Offences accounted for 17.7% of the Leduc Municipal Detachment's CSI.

The top ten CSI contributors, listed in the table to the left accounted for a combined total of 78.7% of the Leduc Municipal Detachment's CSI.

The largest driver to the decrease in CSI from 2022 to 2023 was a decrease in Theft of Motor Vehicle offences. There were 52 less in 2023 than in 2022. This caused a CSI decrease of 2.1 points.

The top 3 drivers to the decrease in CSI, as well as the top 2 increases can be found in the tables below.

LPACT

POLICE PACT

- Since End of April 2024 LPACT has tended to 104 Calls for Service
- Shifts LPACT is working averages to approximately 4 Calls for Service per shift
- 17 Screenings have required immediate Form 10 Apprehensions.
- 42 in person assessments completed
- A shift that has happened is assisting clients with resources regarding doing psychiatric medication reviews and connecting them with resources.
- LPACT has been in operation for over a year, has worked almost 250+ files...
 - ZERO USE OF FORCE WITH INTERVENTION WEAPONS NEEDED.



LPACT Continued

Highlights

- LPACT has been educating community partners about the resources and support LPACT can provide as well as general duty members.
- A highlight has been numerous clients in the geriatric population experiencing late onset delusional disorders. LPACT assisted them and since they were Apprehended on a form 10, they have been discharged, taking new medication, and have not needed police service presently.
- Assisting General Duty with a Suicidal and homicidal male who was going to be released from the health care system. Firearms seized by members and liaised with health staff to ensure the male was readmitted for emergent mental health assistance.



Crime Reduction Unit

Leduc RCMP Crime Reduction Unit (LCRU) took carriage of this investigation. With the assistance of the Central Alberta District Crime Reduction Unit, RCMP determined a stolen welder and welding trailer were at a residence in the South Park area of Leduc.

LCRU with the assistance of Leduc's General Investigation Section and Drug Unit, executed a search warrant at the residence in Leduc and seized 40 welders with an approximate value of \$140,000.

One male was charged with possession of property obtained by crime over \$5,000 and possession of property obtained by crime for the purpose of trafficking over \$5,000. Court is still ongoing.



Crime Reduction Unit

Leduc CRU is actively working on multiple files where 2 suspects have entered LRC change rooms and stole stuff from lockers. We believe it is the same 3 suspects. These suspects have been identified and are currently being targeted by the EPS Prolific Offender Management Program as well. Leduc files are ongoing.



General Investigation Section (GIS)

Rural Home Invasion where an elderly male was beaten and threatened with firearms and many items in his home were stolen. This lengthy and complex investigation required 11 various Judicial Authorisations which included DNA comparison and video surveillance that led to one suspect being interviewed and charged this quarter. Investigative efforts are still ongoing for the remaining 2 suspects.





General Investigation Section (GIS)

In the last month, a robbery with a firearm occurred at a local bar. The investigation culminated in a warrant for arrest being issued for a transient individual responsible for the offence.

A second robbery with a firearm occurred last week and Leduc GIS is currently utilising investigative methods which include identifying and obtaining statements from witnesses, video canvassing and two photograph-lineup's.



GIS-Drugs Unit

<u>Trafficking – Schedule I: Methamphetamine 5(1) CDSA</u>

The Leduc Drug Unit concluded a drug trafficking investigation with a search warrant at a residence in Leduc. 30 grams of Methamphetamine, 25ml Gama-hydroxybutyrate, Cocaine, MDMA, Psilocybin, digital scales and baggies were all located as a result. Value of drugs seized is approximately \$2,523.00. One male from Leduc was charged with three counts of trafficking methamphetamine and two counts of

possession for the purpose of trafficking.



The Leduc Drug Unit concluded a drug trafficking investigation with a search of a vehicle in the area of Leduc. 246g of Methamphetamine worth approximately \$17,000 was seized along with \$5,930 in cash. A female from Leduc was charged with possession for the purpose of trafficking Methamphetamine and possession of proceeds of crime.

Ongoing Investigations


